- Be new resident of Cedar County to receive \$1000 Cedar Live Incentive
- Must be a new resident and newly employed by Local Home Base Iowa employer to receive the \$2500 Cedar Live & Work Incentive
- Must be honorably discharged
- Provide proof of new county residency
- Complete the Eligibility Application
- Submit within 6 months of new employment and/or residency*



Additional Hometown Incentives:

In select Cedar County communities you may qualify for additional local incentives. Contact your city office to see what may be available to new residents.



* Incentives funds are limited per year and not guaranteed to be available for all applicants.

When visiting the Cedar County Veterans Administrator ask about State Of Iowa Incentives you may qualify for including Military Pensions State income Tax exemption, \$5000 grant towards home purchase and immediate in-state tuition at state universities and community colleges.
